

Sterne Kessler Succeeds in Motion for Class Certification for Detained Immigrant Children

Washington D.C. (April 26, 2019) - Sterne, Kessler, Goldstein & Fox is proud to announce success in a motion for class certification in *JECM v. Hayes*, together with co-counsel Legal Aid Justice Center and the Southern Poverty Law Center. In a hearing held on April 26, 2019, in the Eastern District Court of Virginia, Judge Brinkema informed the parties that she would be granting the motion on behalf of the child plaintiff class and the sponsor class.

The lawsuit alleges that the Office of Refugee Resettlement (ORR) policy of sharing information about sponsors and household members with Immigration and Customs Enforcement (ICE) results in the prolonged detention of unaccompanied minors in its care, which is inconsistent with ORR's statutory responsibilities to the children. The classes include children detained in ORR custody across Virginia, and their sponsors anywhere in the United States.
