

## Sterne Kessler Hosts Virtual Pro Bono Clinic for Small Businesses

**Washington D.C.** (April 16, 2020) – In partnership with the <u>D.C. Bar Pro Bono Center</u>, Sterne, Kessler, Goldstein & Fox hosted a free law clinic for D.C. small businesses in need of intellectual property assistance. This event, which has been held in-person at the firm offices for the past several years, was conducted virtually using video, phone, and live chat collaboration tools today. With small businesses and nonprofits being hit particularly hard by the COVID-19 crisis, this clinic gave local organizations the opportunity to receive legal advice at no cost to protect their intellectual property.
